



#### **Overview**

Founded in 1847, Hapag-Lloyd is the world's fifth largest container liner shipping company. Headquartered in Germany, Hapag-Lloyd's over 300 modern ships offer high quality worldwide shipping focused on quality and supported by 16,900 employees in more than 397 offices across 139 countries.

Third Party Questionnaires can also be triggered where the Hapag-Lloyd Compliance team require further information.

#### Periodic Review:

The Hapag-Lloyd Compliance team leverages the Ethixbase360 platform and Ethixbase360's in-house team of Enhanced Due Diligence analysts to conduct initial enhanced due diligence, and periodic reviews based on a cadence dictated by Hapag-Lloyd's compliance policies.
