Background

Some things get better with age – wine, friendships, and institutions like Business NSW. Founded in 1826 as the Sydney Chamber of Commerce, the nonprofit organization has a long history of advocating for and serving the needs of small businesses in Australia.

Today, Business NSW boasts approximately 70,000 members, 760 employees, and 42 offices across the country, plus over 2,000 on-hire workers that it deploys to clients at any given time. The organization is older than the Commonwealth of Australia, which became a nation in 1901.

Successful acquisitions have driven Business NSW's growth and expansion over the course of its long history. The company maintains a diverse business presence through its various divisions, including a law firm and a recruiting agency that places workers in hospitals and nursing and age care facilities. My Business is the online portal for members and the name of the division that develops products and services. Many people are familiar with Business Australia, a brand the organization used in the past.

Business NSW stays on the cutting edge to thrive and adapt in a fast-changing business landscape, especially when it comes to due diligence and risk management. The company partnered with Ethixbase360 to conduct rigorous screening, evaluation, and ongoing monitoring of its supply chain, which includes vendors of personal protective equipment and uniforms, information technology and communication products and services, and construction materials and equipment.

Challenge

Not too long ago, Business NSW struggled in evaluating potential suppliers. Under its previous platform, screening and vetting were conducted after a contract was signed. Suppliers were charged for due diligence.

"The model we were using before just didn't work," said Neha Amin, Head of Legal and Privacy Manager. "We weren't getting any traction. It required the supplier to pay, so it was causing friction. And it wasn't meeting our objectives around what we needed to understand about our suppliers."

Since due diligence happened post signature, suppliers lacked the motivation to cooperate, which meant the Legal Team got stuck in endless follow-up. "We had no leverage," explained Neha. It became clear that they needed a change.







"Ethixbase360 is so simple, so easy to use. It was like night and day for us," said Neha. "The dashboard makes it easy to absorb information and track things that are outstanding."

The law is designed to combat human trafficking, child exploitation, forced labor, and other worker abuses. It requires companies and other entities to report on how they're ensuring that their suppliers and third parties are not engaging in modern slavery.

Ethixbase360's Modern Slavery Questionnaire, developed with the global law firm Norton Rose Fulbright, was a competitive edge noted by Neha. As she put it, knowing who made the questionnaire gave her team "a lot of comfort."

The company's previous system required suppliers to upload documents to support their responses, a big stumbling block. That all changed with the new platform. "The Ethixbase360 questionnaire is straightforward and not onerous for our suppliers," added Neha.

Ethixbase360 is intuitive even for infrequent users like suppliers. "It's very easy for suppliers to access and answer the questionnaire."





Best-Practice Risk Management Process: It used to take Business NSW weeks and sometimes months to screen suppliers post signature. With Ethixbase360, screening comes before a contract is signed, compelling suppliers to respond promptly.

The platform alerts a supplier about the request to complete the Modern Slavery Questionnaire and easily prompts them to navigate the platform from start to finish. Ethixbase360's best-practice process reduced the screening turnaround time from months to one or two days.

Instant Screening and Ongoing Monitoring: Ethixbase360 provides instant screening and insight on supplier risks, and it doesn't stop there. "Continuous monitoring happens automatically from the moment we save the suppliers in the system," said Neha. She likes the fact that such a feature doesn't have to be deployed separately. For Business NSW, any supplier that requires legal review gets added into the Ethixbase360 system.

Due Diligence Commensurate with Risk Level: With Ethixbase360, Business NSW can make sure that its suppliers get the attention proportionate to their risk level. The platform automatically escalates due diligence for timely remediation of issues involving higher-risk and/or material third parties.

The questionnaire is offered by Ethixbase360 via its Ethixbase360 Third-Party Risk Management platform and is an integral component of the Ethixbase360 Human Rights Module. The questionnaire applies know-how developed by Norton Rose Fulbright using its global expertise in identifying and assessing modern slavery and human rights risks, to provide an indicative risk rating. The rating can be used to assist organizations to manage modern slavery and human rights reporting obligations in multiple jurisdictions.
